REACH (Registration, Evaluation, Autorisation and Restriction of Chemicals)

Dear Sir/Madam,

We have received your request concerning REACH. We would like to comment as follows:

Within the framework of the European chemicals regulation REACH, a product is generally divided into the categories substance, polymer, mixture (preparation, formulation) and article. The legislation REACH only allows a registration possibility for chemical substances.

As Schneider neither manufactures chemical substances nor imports substantial quantities from countries outside the European Union, our company is only a so called downstream user. This also means that Schneider cannot notify or register our Schneider products at the European Chemicals Agency (ECHA).

As a producer of articles, we are required to inform our clients according to article 33 of the REACH legislation, if any of our products contain substances of very high concern (SVHC-substances) in a mass concentration exceeding 0,1 percent. The list of substances of very high concern are published on the website of the European Chemicals Agency (ECHA).

We take this obligation to provide information very seriously. In your own interest and against the background of a high level of delivery and product security. We comply with the legal requirements according to Art. 33 of the REACH regulation with the following procedure:

- We are in close contact with the suppliers of the relevant raw materials that are processed in our products. We require them to inform us if the raw materials contain more than 0.1 percent by mass of listed SVHC substances.

- Schneider itself does not add any SVHC substances to the bought substances and formulations.

Currently we only know lead as SVHC substance, which is used in amounts > 0.1% w/w, e.g. the nib of various products. No other substances are currently known to us.
